Education & Outreach

The Dawson County Woman's Club maintained the small gardens in downtown Dawsonville throughout the year. On June 25, 2022, as a culmination of Pollinator Week, a Pollinator Tour was offered for the general public to learn about pollinator plants and the insects that need them. Two Parks were on the tour, each having many examples of preferred plants. These Parks and seven smaller Pollinator Spots were highlighted in the local newspaper. in addition, three members of the DCWC prepared and hosted visitors to their pollinator gardens in their own landscapes. These were the highlight of the Tour, having stunning examples of plants, literature, free plants and seeds for visitors. Handouts were available at all Pollinator Tour sites.
